Remains of NC Soldier KIA McDuffie Identified, Returned Home

The Defense POW/MIA Accounting Agency (DPAA) announced that U.S. Army Pvt. 1st Class Clem D. McDuffie, 18, of Hamlet, NC, killed during the Korean War, was accounted for August 26, 2024. In the winter of 1950, McDuffie was a member of Item Company, 3rd Battalion, 31st Infantry Regiment, 7th Infantry Division. He was reported killed in action on Nov. 30 after his unit was attacked by the Chinese People's Volunteer Army as they attempted to withdraw near the Chosin Reservoir, North Korea.U.S. U.S. forces were unable to return to the area to search for remains as the loss area was in enemy held territory, and the U.S. Army issued a finding of Non-Recoverability on Jan. 16, 1956.

In 1954 the United Nations Command, the Democratic Peoples Republic of Korea (D.P.R.K. or North Korea) and the Chinese Peoples Voluntary Forces exchanged the remains of fallen service personnel in an effort called OPERATION GLORY. All unidentified remains were interred in the National Military Cemetery the Pacific AKA the Punchbowl in Honolulu, Hawaii.

On March 29, 2021, the DPAA disinterred from the NMCP remains reportedly from the Chosin Reservoir Area and began further identification efforts (Phase 3). With advanced technology in DNA Donald was accounted for August 26, 2024, and his family was notified. McDuffie's name is recorded

FROM THE LEGISLATIVE COMMITTEE

The VFW have numerous talking points that are being pushed in Washington, DC. Some of those points are the Guard VA Benefits Act. H.R. 1139(Don't Feed The Sharks)

H.R.4157 Not Just a Number Act. It deals with Benefits and Suicide Prevention.

H.R. 3933 TAP Promotion Act. This bill will insure that accredited personnel would be available so that the transition from active duty to civilian would be smoother while applying for benefits.

H.R. 8371 Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act This bill will increase the access to home and community-based care programs for veterans and their caregivers.

Please continue to reach out to your Representatives about these bills that are being pushed on behalf of veterans. If you don't know who your Representative is please send me an email at Dolphustroy@ymail.com. Soon we will back on Capitol Hill from March 2 -6, 2025 lobbying on behalf of our veterans. We need your help in this fight. When it's time to go to Raleigh, NC when they come back into session let's have a huge number there to show our support also.

Annual Memorial Held For USS Cole Sailor





-Salisbury, NC

Seventeen sailors aboard the USS Cole were killed on October 12, 2000, in a suicide bombing by al-Qaeda. One of those, Mess Management Specialist, Lakeina M. Francis, was from Goldsboro, N.C.

She enlisted in the Navy on April 11, 2000 and attended Basic Training in Great Lakes, Illinois. Francis then went to Gulfport, Mississippi, to Mess Management specialist school. She reported to USS Cole (DDG-67) on September 27. Fifteen days later she was killed in the line of duty. She was 19 years old.

Naval History and Heritage Command website states that Mess Management Specialist Seaman Francis was posthumously awarded the Purple Heart, Combat Action Ribbon, and Navy Unit Commendation. She is interred at the Salisbury National Cemetery.

Salisbury Post 3006 has placed a wreath annually in honor of Seaman Francis. This year, Post Commander, Jim Fox, and Post Chaplain, Harold Andrews, led the service. Special remarks were made by Department Commander, Annie Cummings. Department Adjutant, Alecia Judd, laid flowers. Past NC Department Commander, Tim Woods, was stationed on the USS Duluth, and his ship was one of those that responded to the attack. Since moving to NC 15 years ago, he has attended the annual event. He and Commander Cummings laid the wreath.





It was a great honor to attend such an event; I met some new friends from Australia & within the Dept of the Pacific & multiple VFW Post within the Philippines.





MY NAME IS JAMIE

Publishers note: While we strive to make sure our veterans know they are supported and loved, especially on Veterans day, this story strikes a more sober tone of a problem among many of those who served this country. I felt it fitting to include Jamie's story. May we never miss an opportunity to serve those who served us.

Have you ever thought how it feels to be homeless? To have no home of your own, to live on the streets, under the bridges, in a car, in a condemn room, in cardboard boxes?

Today, homelessness is near epidemic proportions in some areas of the United States.

In our own back yard, the Brunswick County, at any given night, there are at least 86 individuals who do not have safe permanent housing. Contrary to much belief, 80% of the homeless are families with children. Amidst the growing affluence in Brunswick County, homelessness is increasingly a significant challenge.

Let me put you in the shoes of a homeless person to fully appreciate the things a homeless person goes through. After which I hope that you will find in your heart to take action to help make a difference. Any way you can.

This is a true story written in his own handwriting by a homeless veteran who I met and helped while I was working for the VA Hospital in Pittsburgh.

"My name is Jamie. I am in what are supposed to be my "golden years." I am made up of a ball of mass confusion and very low self-esteem. I have been unstable for the past 10 years and have been homeless 3-4 times all over the United States. I have lived in bridges and literally froze to a point of hypothermia.

I started from Long Beach, California. I got robbed of the last \$80 I had. It took me 3 days to get to Las Vegas. I hitchhiked. I then went to Utah. I got a job and stayed there for a year. I lost my job. I hitch hiked for miles and miles with my pit bull, the only bright thing in my life. I ended up in North Carolina. I met a very nice girl, got married and had 2 kids. I tried very hard to make a life for myself and family. But after 8 years, my family left me. I could not provide for them. Housing has become too expensive and could not afford a decent home. Once again, I had become homeless. I wondered all over the United States leading a life of no direction. It is a very scary world to be all-alone.

I suffer from manic depression, severe nervous disorder, agoraphobia and chronic loss of memory. This was a result of my horrible experience in the Vietnam War. I have not been diagnosed properly and I have gotten very little help emotionally and financial by the country I have served so unselfishly.

I do not remember how I ended up in Pittsburgh. A very kind person referred me to the Veterans Hospital where they diagnosed me properly and help me to slowly put my life together. After all these years, my life has begun to change for the better. I see the light at the end of the tunnel. I am grateful to the help of all the people around me. That is just a very small gleams of the life of a homeless."

Homelessness cannot be ignored. We cannot ignore the fact that even in our very own Brunswick County we have many Jamie's among us. The homeless may not be as clean or as well dressed like you and me, but they are people. They have a heart, a soul, and are children of God just like you and me. I therefore challenge you to help out our less fortunate brothers and sisters by finding it within your heart to help out in any way you can to make a difference in their lives.

Cape Fear Voices (CFV) is a nonprofit organization that promotes creativity through its online publication, which showcases the literary and artistic works of adults and teens. Founded in 2004 by Gerald Decker, CFV started publication in the Cape Fear area in 2020. We have actively promoted journalism and audio/visual production in several area schools.

The North Brunswick Chamber of Commerce awarded us the "Nonprofit of the Year, 2024." Currently, we are expanding our program by adding a tri-county audio/visual program for our selected students called WTSI for W-Teen-Scene-Inc.


